

Airstar Personal Instalment Loan Promotion Offer
(Apply via Centaline Mortgage Broker Limited (“Centaline Mortgage”))

Terms and Conditions (“Terms and Conditions”)

(Revised [29 December 2020])

Enjoy HKD 200 cash reward once application submitted (“Offer 1”)

1. The promotion period is from 19 November 2020 to 31 March 2021, both dates inclusive (“Offer 1 Promotion Period”). The promotion offer is only eligible to customers apply via Centaline Mortgage (the “Partner”).
2. To qualify for the reward, the loan applicant must register mobile number via Airstar Bank (“the Bank”)’s designated link (<https://www.airstarbank.com>) and apply the loan successfully via mobile application within 30 days of the registration (“Offer 1 Eligible Customers”).
3. By the time of registration via the Partner, Offer 1 Eligible Customers have not registered for any promotion offers from the Bank on any other loan referrer websites, and must not hold any loan account of the Bank or submitted any loan application to the Bank, and must not hold, have not cancelled or have not held any loan account of the Bank within the past 6 months prior to the time of loan application.
